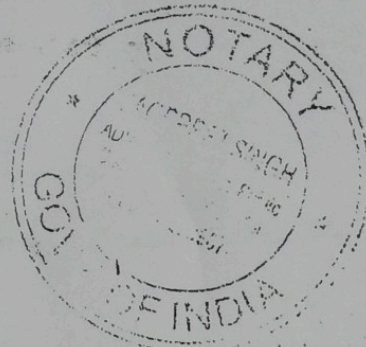

Subject : Regarding the issuance of No Objection Certificate for obtaining affiliation with CBSE New Delhi to Shri Guru Harkrishan Public School, Seel Road, Raipur Bahadurgarh, Distt. Patiala.

In the reference of the above cited subject.

After giving a thorough consideration to the documents including affidavit submitted by the school management, the recommendations of Distt. Education Officer [Sec. Edu.] Patiala and Director Education Deptt. [S.E.], Punjab, Chandigarh, the desired NOC is issued by Punjab Govt. on the under mentioned conditions :-

1. In case, the fact comes in light in any of the complaints/inspections in future that you had appealed to the government for NOC on the basis of wrong information and/or you had not complied with the instructions issued from time to time by the Punjab Govt. and hence the written conditions given in the affidavit are not followed by, then in such condition the NOC can be withdrawn back at any time.
2. In your school, teaching of Punjabi will be compulsory at secondary level and CBSE New Delhi will make sure to conduct exam of Punjabi in such schools and further it is also said that failing to implement it, the NOC will be taken back immediately.
3. The school management shall comply with the notification issued under RTE Act 2009 by Punjab Govt. and the rules of RTE Act 2009 made for Punjab State, as is there is.
4. After obtaining the affiliation of CBSE New Delhi, The School Management will be bound to issue the salaries and other allowances through account payee cheques to the teaching staff and no teaching staff like Government employees. Failing this, the NOC will be taken back immediately.
5. You yourself and your management too will make sure that whenever the Education Officer of your district or any senior officer of education department asks for any information, the necessary information will be made available to them and required co-operation may also be given. Failing this the NOC will be taken back immediately.
6. The safety of the children, public health, sanitation and the conditions of issuance of other NOCs, will be inspected by the officers of Punjab Government from time to time.

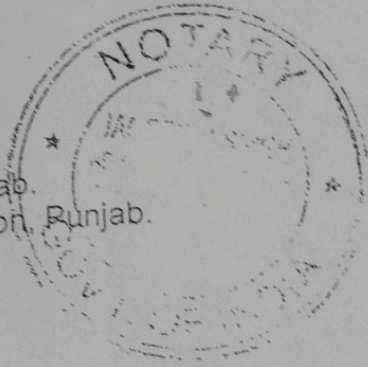


